

## International Adoption Program Fees for Service

The Barker Adoption Foundation is non-profit and derives less than 50% of its revenue from fees for services; the remainder comes from contributions, fund raising and other grants. Adoption services are costly because of the time intensive nature of the counseling process and because of the extensive requirements of both the courts and state licensing. Fees are for services rendered and cannot guarantee the placement of a child. Fees are adjusted periodically.

<b>Post placement/adoption Deposit</b> Required for all families in Barker's direct programs, including China, Korea, India, and Colombia. Refundable when all post placement/adoption obligations are fulfilled.	\$1,000 (refundable)
